Dear Parent/Carer,

We are delighted to inform you that we have arranged to take our Year 7 and Year 8 students on a residential activity trip to **PGL Osmington Bay Adventure Centre, Dorset**, from **Wednesday 15th July to Friday 17th July 2026**.

The total cost of the visit to PGL Osmington Bay will be **£383.20**. **If your child is eligible for Pupil Premium, please complete the financial assistance form available on our website if you would like support with your child's participation in Camp.**

The total cost includes: Accommodation; All meals; Transport to and from the centre; Fully qualified instruction during activities; Specialist and safety equipment; An evening activities programme; Achievement certificates; Comprehensive insurance

To apply for a place for your child, please ensure the consent form and reply slip is returned to the Office by no later than **5th November**.

To secure a place for your child, you will need to log into Arbor to pay the **initial deposit of £40**. Please make your deposit payments by **Friday 7th November** in order to allocate their booking.

*If your child is eligible for Pupil Premium funding and need support with the initial payment (deposit), please indicate this on the reply slip. The school may be able to allocate funding to secure your child's place, as we appreciate the short turnaround time. The £40 deposit will then be added to the remaining Pupil Premium balance and can be paid in instalments.*

The remainder of the trip cost may be paid in full or in instalments.

*Please note that there are only 40 spaces available for this trip. Places will be allocated on a first-come, first-served basis, based on the deposit payment.*
